## MACHINE LIMITED WARRANTY

Tru Tech Systems, Inc. warrants to the original purchaser only that all products manufactured by it will be free from defect in materials or workmanship for a period of 1 year (12 months) from the date of delivery to such purchaser. Warranty covers both parts and labor, in accordance with all applicable terms of this limited warranty.

Such warranty will remain in effect if and only if such products are used in accordance with all instructions as to maintenance and operation set forth in user manuals, instruction sheets, videos, training materials and software tutorials furnished by Tru Tech Systems.

This limited warranty DOES NOT cover the following (list not all inclusive):

- Any equipment or components that have been altered or modified without express written consent from Tru Tech Systems, Inc.
- Any intentional or negligent acts, misuse or abuse of the equipment by the purchaser/end user
- Failure to perform required or recommended maintenance and care both routine and preventive (including filtration systems, dressing of wheels and other tooling)
- Failure to follow safety guidelines or written instructions designed to protect the user or equipment, including crashes caused by operator error or improper use of equipment
- Tampering with or removing safety devices and guarding provided with equipment
- Attempting to repair or disassemble the equipment or electronics without proper training or authorization from Tru Tech Systems and thereby causing a failure
- Use of unapproved accessory items or failure to use proper tooling and accessories
- Tampering with or modifying the Tru Tech software or adding third party software to the machine
- Perishable tooling and accessories (i.e. – timing belts, light bulbs, dressing wheels, etc)
- Failure or destruction that may result from fire, weather, electrical power surges, property destruction, or acts of God
- Tampering with the precision unit , modifying or disassembling the unit in any way, shape or fashion

Tru Tech Systems' liability under this warranty is limited to delivering to the owner F.O.B. Mount Clemens, Michigan, USA equipment or parts determined by Tru Tech Systems to be defective, or repairing at its plant such equipment or parts determined by Tru Tech to be defective and returned to Tru Tech Systems' plant freight prepaid. Tru Tech Systems reserves the right to repair or replace any part deemed to be defective as it sees fit. This warranty includes labor for service, either by phone or in person to resolve issues pertaining to or resulting from defective materials or workmanship.

This warranty shall not cover or obligate Tru Tech Systems in any way regarding items, accessories or components not manufactured by Tru Tech Systems, which items or components will carry only the standard warranty of the manufacturers thereof. Unit rebuilds carry a 6 month warranty from date of shipment. Accessory items carry a 90 day warranty from date of shipment.

In no event shall Tru Tech Systems be liable for any consequential damages that arise from the use of its products, including but not limited to damages from loss of use, or damages for loss of profits or income. This warranty may not be assigned, transferred or sold in any way and extends only to the original purchaser.
